Project for Recording Assam's Traditional Health Activities (PRATHA), funded by AYUSH, Government of Assam, collaborates with the Centre for Indian Knowledge Systems (CIKS), IIT Guwahati to record medicinal plants, therapies, and ethnomedicinal practices. It bridges traditional wisdom and modern science through a digital repository, involving healers, researchers, and students. The project involves Survey to identify Traditional healers in Assam with specific objectives:

1. **Benefits for Traditional Healers:** Documentation protects against biopiracy by creating verifiable records, preventing unauthorized patenting of tribal knowledge as seen in past Indian cases. This shields healers from exploitation and enables benefit-sharing under laws like the Biological Diversity Act 2002.
2. **Entrepreneurship Opportunities:** Village-level surveys can evolve into validated products, fostering rural startups in herbal therapies or eco-tourism. Healers gain recognition, market access, and income via community enterprises, aligning with AYUSH goals for sustainable healthcare.
